d) To Whom and For What Purpose the Processed Personal Data Can Be Transferred

Your personal data will be transferred without seeking the explicit consent of the person concerned in accordance with Articles 8 (2) (a) of the KVK for the following purposes:

It will be shared with the General Directorate of Security in order to fulfill our legal obligations arising from the relevant legislation.

- It can be shared with notary public, enforcement offices and / or courts, if necessary, in order to carry out financial and / or accounting issues within the scope of collection of fees for products and services.
- In order to fulfill the legal obligations in accordance with the relevant legislation, if required or requested, it can be shared with the relevant public institutions and organizations.

- It will be shared with the contracted courier company to deliver the items left and forgotten at the hotel.
- In order to follow the legal processes, it can be shared with our lawyers as required within the framework of the confidentiality obligation.

Do We Transfer Your Personal Data to Third Persons in the Country?

Competent Authorities:

Due to the legal regulations in our country, we share identity data, communication data and many other personal data listed above with the authorities explicitly authorized by the legislation periodically or upon their request.

In addition, your personal data are shared with authorized persons or institutions upon the request of a court decision or an administrative authority expressly authorized by law.

e) Method and Legal Reason of Personal Data Collection

Your personal data are obtained verbally, in writing or electronically by automatic or non-automatic methods, based on the legal reasons specified in articles 5 (2) and 6 (2) of the KVKK in order to fulfill the purposes specified in paragraph (c) of this text:

- Filling out the form by the person concerned, sending an e-mail message, contacting by phone call, visiting the website and contacting via social media platforms.
- Sharing business cards in online sales platforms, tourism agencies, organization companies, fair or seminar visits, and communicating them through solution partner institutions or organizations.

YOUR RIGHTS IN ACCORDANCE WITH ARTICLE 11 OF THE KVK

Within the scope of the KVK, we are aware that the person concerned has the right to "be enlightened" and "obtain his consent" before the processing, recording, transfer, sharing and storage of his personal data, and that he has the right to "determine the fate of his data" after the data is processed, recorded, transferred, shared and stored. In this context, as personal data owners, if you submit your requests regarding your rights to DİZAL TURİZM İŞLETMECİLİK VE TİCARETA.Ş., with the methods set out below in this "Clarification Text Regarding the Processing of Personal Data, we will finalize this request free of charge within 30

days at the latest, depending on the nature of your request. However, if the transaction requires an additional cost for the Company, the fee in the tariff determined by the Personal Data Protection Board may be charged.

In accordance with the "Communiqué on the Principles and Procedures of Application to the Data Controller" published by the Personal Data Protection Board, we are obliged to share the following information in this text while meeting your requests regarding your rights as a "personal data owner":

In this context, personal data owners;

- a. Learning whether personal data is processed,
- b. If personal data has been processed, to request information regarding this,
- c. Learning the purpose of processing personal data and whether they are used in accordance with their purpose,
- d. To know the third parties to whom personal data are transferred domestically or abroad,
- e. To request correction of personal data in case of incomplete or incorrect processing and to request notification of the transaction made within this scope to third parties to whom personal data are transferred.
- f. To request the deletion, destruction or anonymization of personal data within the framework of the conditions stipulated in Article 7 of the KVK and to notify the third parties to whom the personal data is transferred,
- g. Object to the occurrence of a result against the person himself by analyzing the processed data exclusively through automated systems,
- h. In case of damage due to unlawful processing of personal data, it has the right to demand the compensation of the damage.
